New Business

- Chapter 38 recommends: TTS Registration allow a member to register for only ONE discipline. Rationale: If a member is already certified in all disciplines, except one.
- Chapter 38 recommends: Update membership policies, to eliminate the 7-year rule expiry of TTS qualifications to be used for membership application. Rationale: How can exam done 13 years ago be credible, but not someone who completes 4 years of TTS
- Chapter 38 recommends: Online store able to ship to Canada. Rationale: Canadian chapter cannot get anything delivered from the online store.
- Chapter 38 recommends: The Solo Title Acro Class add a phase 6, an aerial or limbering section. Rationale is that currently contestants can go through the audition showing no aerial or limbering skills.

- Chapter 16 recommends: Use for formal gowns during awards for female contestants be reinstated. It is also our recommendation that the strict rules regarding formal attire (gowns) be eliminated. Rationale: The use of formal attire exemplifies the level of class and professional standards that our National Title event holds.
- Chapter 28 recommends: A Teacher of Record or a Chaperone be allowed to accompany a dancer to Nationals. Rationale: The Teacher of Record is not always able to attend especially when they must commit so far in advance. Filling out the change of chaperone form should be sufficient and without penalty regardless of why the Teacher of Record is unable to attend. In our chapter's opinion life happens and we need to help our members if they are unable to attend. It is our recommendation that changes be allowed without consequence until whatever date the national board deems necessary, such as June 15th in order to have a successful event.
- Chapter 28 recommends: The National Board consider using a birthdate of January 1st for cutoff of ages as this is the age all other standardized competitions use. Rationale: This would simplify the registration process for studio owners and competition directors. We have several times where a student is entered incorrectly simply because a well-meaning member has forgotten about the June 1st cutoff date.
- Chapter 28 recommends: The National Board consider the use of payment through a credit card or some other electronic method. We know there are fees associated with this method and those may need to be passed onto the studio owners if they choose to use this method. Rationale: The mail service has not always been dependable in getting checks to our treasurer in a timely manner. This causes stress and extra expense.
- Chapter 46 recommends: Ballet be a required audition class and for the score to count for all dancers.
- Chapter 46 recommends: The scoring of audition classes percentage weight be balanced across all divisions of the competition. Rationale: So that all phases of the competition are comparable in terms of contribution to total score.
- Chapter 46 recommends: The 89% threshold for solo title qualification be reconsidered. Rationale: To encourage more participation.
- Chapter 46 recommends: Solo Title contestants introduce themselves at the microphone after the opening number and outgoing titleholders introduce the new contestants. Rationale: Our members believe the ability to speak articulately with energy in a public forum is an important characteristic of our dancers and the opportunity supports them to develop that skill.

Above recommendations will go to the Executive Committee for consideration and reported at the Board of Directors meeting.
